1. I hereby agree to all of the conditions for the race related activities which I have read or will read and understand.

I hereby agree that I have sole and inescapable responsibility for the safety of my yacht and for the safety of my crew and guests; that it is my responsibility to see that the yacht is fully sound, thoroughly seaworthy and manned by an experienced crew who are physically fit; that it is my sole and exclusive responsibility to decide to sail or power to Put-in-Bay and join the racing fleet; to participate in the race related activities; whether or not to continue participating in such activities, and when to sail or power from Put-in-Bay. I also agree that I will abide by the dockage restrictions as required by the Put-in-Bay dockmaster and enforced by the Mills Race Committee.
3. I do for myself, my executors or administrators, heirs and assigns, waive any and all claims as may accrue to me or them against the Mills Trophy Race Committee, its subcommittees, its supporters for the race and related activities, its sponsoring and host clubs, their officers, directors, members, employees and agents, and any one or more of them arising out of the participation of my yacht in this race or arising from any related activities. I do further agree to and do hereby indemnify the afore said organizations and persons from any claim, demand or judgment against them, including cost, attorneys fees, and expenses incurred in defense of such claims, etc. made or brought by a guest or crew member of my yacht or their executors, administrators, heirs, next of kin, and assigns arising out of my yacht's participation in the race or any related activities.
